CHAIRMAN'S REPORT

COMMUNITY

We continue to be excited about the future impact Hawke's Bay Foundation will have on our community and are grateful to our current donors for their belief in us. We are amongst the youngest of Community Foundations within the Community Foundations of NZ group of fourteen nationally, who had combined Funds under Management of \$55m at 31 March 2016. This reinforces the fact that many people like to "give where they live". As a group, we share knowledge and experiences freely which provides a great source of motivation especially when looking at the more established ones that are now having a seriously positive impact on their local community.

Over the last year our Board has grown by one, with Giles Pearson joining the team. Giles brings valuable accounting experience to the table but of equal importance is the energy he has to give and his connectedness within our community. We are incredibly fortunate to have a Board made up of individuals who are generous with not only their skills, but also their time which they give so willingly for Board meetings & governance, meeting with prospective donors, giving presentations to groups etc. In addition to this, they have all made a financial commitment to HBF which is a true reflection of their belief in what we are doing and essential in terms of being able to talk the talk credibly.

So, with genuine gratitude, we would like to thank Brian Martin, Andrew Wares, James Williams, Sam Howard, Jessica O'Sullivan, Sarah Mulcahy and Giles Pearson all our Trustees for their ongoing enthusiasm and commitment.

DONORS

We are only able to make distributions possible because of the generosity of those who choose to make gifts and who want to help make our region a better place. The strength of the endowment model strikes a chord with HBF's supporters. They are encouraged by the model, where donations and bequests are invested and inflation-protected so that they keep on working for the Hawke's Bay community forever.

The generosity of our community is superb and in the last 12 months we have received \$460,000 in donated funds and over \$1.1 million in promised funds and bequests. These donations are the lifeblood of the Foundation and we give our heartfelt thanks to our donors for joining us and making a real difference in our community.

We work with our donors to set up a giving plan that works for them, some choose to give now and enjoy seeing the difference they are making, as well as receiving the tax benefits and others are choosing to make a bequest to Hawke's Bay Foundation in their will. Whichever route they choose, it is all for the betterment of Hawke's Bay, forever.

Over the last couple of years we have invested a substantial amount of time in explaining what we are about to law and accounting firms throughout Hawke's Bay, so that they can knowledgeably share this philanthropic concept with their clients. During this past year, we have had several examples of donors that have come to us through knowledge they received from their professional advisor. This is a huge step forward for us and to those firms that have made this happen, a very BIG thank you for being proactive on behalf of your community.

There is plenty of potential for merging of Trusts into HBF, as the way our endowment model is set up is the perfect umbrella for trust funds whose managers no longer want to spend time and energy appointing boards, keeping up with governance, making investment decisions, directing distributions etc. This year we had our first conversion and we know there will be more.

DISTRIBUTIONS

In 2016 we were delighted to distribute \$112,500 to 34 local community groups across health, community and social, arts and culture, natural environment and learning sectors. This brings the total distributions since our inception four years ago to \$950,000.

A big thank you to our Distributions Committee which comprised Chair Sarah Mulcahy, James Williams, Jessica O'Sullivan and myself. A lot of volunteer Trustee time and effort goes in to assessing our annual requests for funding and we really do appreciate their input. Incidentally, each year we receive applications for four times as much as we have to give away which certainly makes the reason for our growth even more essential.

Hawke's Bay Foundation distributes grants to local causes and charities – we wholeheartedly believe it's all about "our community, our responsibility, our future".

INVESTMENTS

The Investment Advisory Committee comprised Chair Brian Martin, Sam Howard and we were thrilled to have Giles Pearson join this committee during the year. Giles brings with him a wealth of experience and expertise. We also have independent advisor Michael Chamberlain of MCA, who provides valuable assistance and oversees the recommendations from First NZ Capital.

Endowment Funds over the last 12 months have increased from \$1 515 791.00 to \$1,844,935.

ADMINISTRATION

Much of the hard work that goes into making much of the above mentioned happen is due to the energy, enthusiasm and commitment of our wonderful team in the office who together work tirelessly and always with a wonderful disposition that is perfect for HBF. We are lucky to have this very dedicated team which together make up one full time paid employee.


We have made a commitment to utilise no more than 1% of our earnings from investment income for administrative purposes, however at this early stage of our growth this is not sufficient to allow us to grow so, in the interim, we are incredibly fortunate to have invaluable support from many businesses and supporters who allow us to continue doing the good work we do Crowe Horwath, First NZ Capital, Band, Brebner Print and there are others who know who you are and choose to remain anonymous. Until our fund is large enough to support our costs through the 1%, we will be indebted to those who can see the vision and support us so generously.

WHERE TO FROM HERE?

It has been a busy year building and strengthening our brand and we are thrilled by what we have achieved.

In 2017/2018 our continued focus will be to spread our word and build our fund so that each year on behalf of our donors we can make a bigger impact on the wellbeing of our community. We will make "Live Here Give Here" a familiar household concept by making ourselves much more visible in the community. To do this we have a number of opportunities in the pipeline and have faith that this can be achieved. As a result, we expect familiarity with HBF to grow and donor interest too.

Thank you again to everyone involved in growing this valuable community resource. Whether it be as a donor, a supporter or a volunteer, generations to come will undoubtedly be incredible grateful for your foresight.

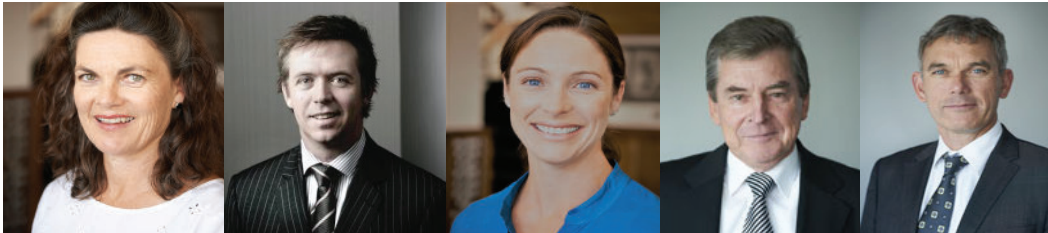

OUR STORY

Hawke's Bay Foundation is a Charitable Trust that receives donations from individuals and families around the region. These funds are pooled and invested in perpetuity. Only the earnings are distributed annually to exclusively support local community initiatives and organisations bringing about positive and powerful social change. Essentially, we are building an intergenerational asset for the Hawke's Bay community – a "nest egg" that will support Hawke's Bay people forever.

OUR PROGRESS

Hawke's Bay Foundation's endowment fund was first launched at the end of 2012 and to date we have over \$2 million under investment, so we are on the right track and moving in the right direction towards our goal of being able to distribute \$400,000 in to the community by 2020.

OUR IMPACT

In the 2016 financial year, Hawke's Bay Foundation distributed \$232,000 to community organisations in Hawke's Bay, supporting children, young people and their families, older adults, community development, health, the arts and the environment. These distributions were made up of a combination of Hawke's Bay Foundation's funds, Tindall Foundation funds and direct donor contributions by way of "pass-through" donations (detailed below).

OUR FINANCES YEAR BY YEAR

Investment advisers First NZ Capital kindly donated their services and managed our funds last year with no cost to HBF. The endowment capital increased from \$1 515 791 to \$ 1 844 935.

DONORS

We wish to acknowledge that the distributions that Hawke's Bay Foundations make annually are only possible because of the generosity of the HBF donors, who together have made the commitment to making our community a better place. We welcomed five new donors, bringing the total number of endowment funds established to 20. While our initial focus has been on making provision for an endowment fund in your Will, more and more people are choosing to contribute to their funds during their lifetime. By doing this, they have the pleasure of seeing their money making a difference during their lifetime and meeting some of the groups that they are supporting.

We also had an increase in Donors who make a regular gift- those that haven't set up a Fund but are making a difference in the way they can. Whether it be \$10 per month or \$100 per year- together it all adds up.

2016 GRANT RECIPIENTS

Hawke's Bay Foundation holds an annual funding round where local community organisations can apply for funding for projects, initiatives and operating expenses. Those organisations are then vetted by the Distributions Committee and granting decisions are made based on the quality of the applicant organisation, and the needs and gaps in the community that are being met.

In the 2016 funding round, Hawke's Bay Foundation distributed \$112,500 to 34 community organisations, from a combination of funds from Hawke's Bay Foundation's and funds donated through Hawke's Bay Foundation by the Tindall Foundation. However in total we received applications for over \$400,000, demonstrating the significant need for funding in the charitable sector. This motivates us to continue to drive the Foundation forward, so that we can meet more of this need in future years.
